NOTES

1. Read the whole form carefully before completing it
2. **USE A SEPARATE APPLICATION FORM FOR EACH PERSON**
3. As decided at Annual General Meeting, all seniors who were members last season who did not attend the AGM or send in beforehand a written apology will be charged £1 extra.
4. Cheques should be made payable to 'Adventure Angling Society'. Unless you are applying in person and producing a banker's card with your cheque, you should allow 14 days for the issue of the permit because of the time it takes for the cheque to clear your bank. Permits paid by cash are processed as quickly as possible after receipt. Please do not send cash through the post even in a registered envelope.

Permits will be issued as early as practical before the start of the season, and it will be appreciated if members will return their application forms, with subscriptions, as soon as possible. If the permits are not available when the first applications are received, there is bound to be some delay while the backlog is cleared first. Please be patient. Before chasing us for your permit, please make sure your cheque has been cleared through your bank account, and, if so, when. This helps us to answer your query quickly. Also keep a careful note of the date you posted your application. If your permit was to be returned by post, did you enclose a stamped addressed envelope with sufficient postage?

5. Permits will **NOT** be returned to postal applicants unless a stamped addressed envelope is enclosed; this envelope should be **AT LEAST 114mm x 162mm**. Please make sure adequate postage stamps are affixed: the complete package will weigh about 100g. **A LARGE 1st or 2nd class will be required**, otherwise Royal Mail will charge you the difference plus £1 admin fee before delivering. Alternatively, you can pay an extra £1 to cover postage and packing on your permit (see front of application form)
6. **All permits are sold on the understanding that a passport sized photograph of the permit holder will be affixed in the appropriate place and signed. Failure to do this will render the permit invalid and may be confiscated and retained by the bailiff. NO FISHING CAN TAKE PLACE WITHOUT THE PHOTOGRAPH**
7. Juniors (under the age of 15) must be accompanied by a senior member when fishing Willow Pool. If you are over the age of 17 years on 16 June 2016 then you are deemed to be a Senior Member. Juniors aged between 15 and 17 can fish unaccompanied provided that a brief letter specifically requesting this privilege is received by the Secretary **BEFORE** fishing.
8. All information on this form will be treated in complete confidence by the Committee.
9. It is very important we have your telephone number, and, if you have one, an e-mail address. Any queries can be resolved much more quickly and simply over the phone. Newsletters and other important information will be forwarded by e-mail. We **never** give out members' phone numbers/e-mail addresses to anyone else, even if they are not ex-directory. So please do put your number/e-mail address on the form.
